Australia's laws promote quality education and consumer protection for overseas students. These laws are known as the ESOS framework and they include the Education Services for Overseas Students (ESOS) Act 2000 and the National Code 2018.

## Education Services for Overseas Students (ESOS) Legislative Framework

International students studying in Australia on a Student Visa are protected under the Education Services for Overseas Students (ESOS) Act 2000. The Act sets out the legal framework for the delivery of quality education by setting standards. The framework also provides tuition and financial assurance through the [Tuition Protection Service \(TPS\)](#).

The Legislative Framework incorporates the:

The legislation aims to protect international students and guarantee quality education.

Please note, the Legislative Framework relates only to students who are enrolled in an onshore program and remain in Australia on a Student Visa. This Legislation does not apply to students undertaking offshore programs or remaining in Australia on a temporary visa other than a Student Visa.

All agents are required to be familiar with and abide by the above Code of Ethics as stipulated under Standard 4.3.4 of The National Code 2018.

### Quality Practices

The College shall not accept students from an education agent if it knows or reasonably suspects the education agent to be:

- Providing migration advice, unless that education agent is authorised to do so under the Migration Act
- Engaged in, or to have previously engaged in, dishonest recruitment practices, including the deliberate attempt to recruit a student where this clearly conflicts with the obligations of registered providers under Standard 7 (Overseas student transfers)
- Facilitating the enrolment of a student whom the education agent believes will not comply with the conditions of his or her visa
- Using PRISMS to create Confirmation of Enrolments for other than bona fide students

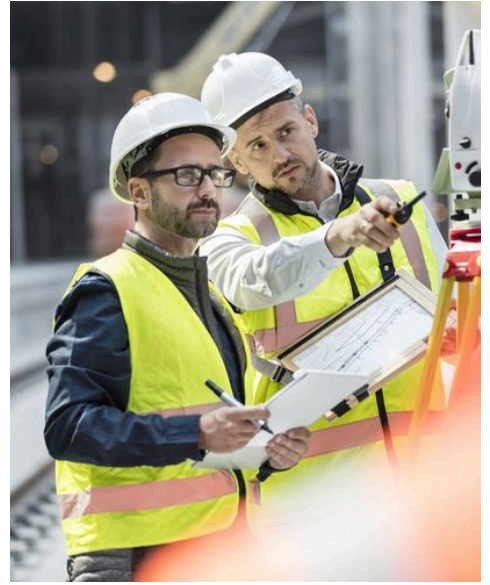

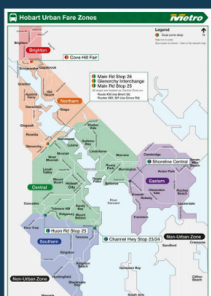

# Must Visit Destinations



**There are so many things to see and do while you are studying in Tasmania, including:**

## **MONA**

The Museum of Old and New Art (MONA) is the largest privately-owned museum in Australia and is located in Berriedale a suburb of Hobart. The museum is interactive, entertaining and completely different from anything else with the use of light, sound, and movement to engage your senses.

## **Hobart's waterfront and Salamanca Market**

Hobart waterfront is a picturesque area of boats, old warehouses, buildings, accommodation, restaurants and floating fish shops. Hobart's Salamanca Market is one of the most popular places to visit in Tasmania and takes place on Saturday morning until 3 pm when 300+ stalls line Salamanca Place.

## **Mt Wellington**

The mountain towers over Hobart and is impossible to miss as a part of this beautiful backdrop to Australia's southernmost city. The mountains are 1271 metres tall and offer fabulous views over Hobart and southern Tasmania.

There are also many surrounding parks and gardens which make a great spot for a picnic after picking some food at the market or visiting some of the great pubs, restaurants, cafes and shops.

## **Huon Valley**

The Huon Valley is located about a 30-minute drive south of Hobart and is home to some great places to see with beautiful scenery. One of the favourite activities in this region is the Tahune Air Walk where you can walk above the tree tops including a 50-metre high hanging section at the end over the river. A little further south you can also visit Hastings Caves and have a swim in the Thermal Springs.

## **Mt Field National Park**

Mount Field is Tasmania's first national park that has great scenery, a good range of walks and plenty of wildlife. Russell Falls is the star attraction with an easy walk that takes you through a fern forest with some of Tasmania's tallest trees. In Winter, there's skiing and snowboarding.

# General English

CRICOS Code : 114771J



The **General English** course at AuSC English Academy is designed to prepare students for conversation, everyday situations, and daily interactions that take place when traveling or living in an English-speaking country.

Students learn and practice the four macro-skills of listening, reading, writing, and speaking in an interactive environment. Levels of difficulty increase over the duration of the course to assist students in developing their skills and to be more confident and fluent in English.

## English language requirements

1. There are **no specific educational prerequisites** for entry into this course, as entry into this level is based on an assessment of English language proficiency. Students will be assessed by Australian Sovereign College at orientation using the **Placement Test** and **interview**.
2. The applicant must be **18 years old or above**.
3. They will then be placed in the appropriate class level as follows:

- Beginner
- Elementary
- Pre-intermediate
- Intermediate
- Upper-intermediate
- Advanced

## Delivery Mode

The General English course is made up of **60 units of study**, each of which is delivered over a week. Face to face classroom only. Teaching methods include teacher-directed and student-centred learning. Delivery will be flexible taking into account the different learning styles, cultures and needs of students.

## Course Outcome

The General English course focuses on everyday functional English and facilitates learner understanding of the language, communication and conventions used in an English-speaking country. The course aims to provide students with a learning environment that is as close as possible to common everyday situations in Australia and is also designed around common student-based requirements.

Successful completion of this course may allow the student to study other ELICOS courses such as English for Academic Purposes or other vocational courses provided at AuSC.

## Overview

This qualification reflects the role of individuals in the community, home or residential care setting who work under supervision and delegation as a part of a multi-disciplinary team, following an individualised plan to provide person-centred support to people who may require support due to ageing, disability, or some other reason.

These individuals take responsibility for their own outputs within the scope of their job role and delegation. Workers have a range of factual, technical, and procedural knowledge, as well as some theoretical knowledge of the concepts and practices required to provide person-centred support.

The skills in this qualification must be applied in accordance with Commonwealth and State/Territory legislation, Australian standards, and industry codes of practice. To achieve this qualification, the candidate must have completed at least 120 hours of work as detailed in the Assessment Requirements of the units of competency.

## Outcomes

This course is targeted at international students who are:

- Seeking to pursue a career in providing individual support
- Seeking to enter a new industry sector
- Seeking a pathway to higher-level qualifications

Completing this course may provide you with employment or learning opportunities. Potential employment options are as a direct support worker in aged care, disability, home and community care or other direct care work in the community services industry.

Students who complete this course may wish to continue their education into the CHC43121 Certificate IV in Disability Support and other Certificate IV qualifications in community services.

## Entry Requirements

Australian Sovereign College has the following entry requirements:

**Be at least 18 years of age** and have completed the equivalent of Year 12.

### Participate in a course entry interview

To determine suitability for the course and student needs. This will also include an LLN assessment and you must achieve ACSF 4 for reading, writing, numeracy and oral communication to enter the course.

**Have an IELTS\* score of 6.0** (test results must be no more than 2 years old).

English language competence can also be demonstrated through documented evidence of any of the following:

- Educated for 5 years in an English-speaking country; or
- Completed at least 6 months of a Certificate IV level course in an Australian RTO; or
- Successful completion of an English Placement Test.

*Note that other English language tests such as PTE and TOEFL can be accepted. You are required to provide your results so that we can confirm they are equivalent to IELTS 6.0.*

You are required to bring your own laptop with Office 365 (or similar program) to all classes.

### Training and assessment information

A face-to-face training, as well as distance mode is employed for this qualification. All classroom-based training will take place at the AuSC.

The structured self-study component of this course amounts to 4 hours a week. Students are provided with access to self-study guide for completion of a range of activities.

The estimated time to complete activities is documented in the guide for each unit. This is a mandatory component of a student's study and student's attendance, and participation will be monitored.

Units of competency are delivered individually. A timetable will be supplied to each student before course commencement.

Students are also provided with an orientation to the course to outline the learning and assessment processes, support services and other relevant information. This forms part of the general orientation that AuSC provides to students.

Students are provided with Student Guides that they will use to develop their knowledge and understanding. Students are also provided with details of further reading (i.e., a textbook) within each Student Guide. Copies of these textbooks are available onsite.
